We look forward to hearing from you and hope to see you at our shopping spectacular this November.

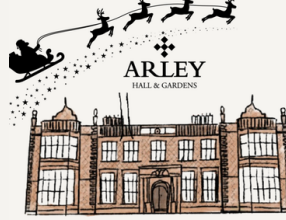

TERMS AND CONDITIONS FOR STAND HOLDERS.

All Traders invited to the Arley Shopping Spectacular must comply with the following terms and conditions:

- Please be aware that the stand space for a single stand is limited to 1 trestle table with a 6ft 3inch frontage with access to the sides and space to the rear for storage ect. If you require a larger space, please consider booking a double or corner stand.
- Stand holders are responsible for providing their own table coverings for all tables, and any additional lighting required for the stand.
- Stand holders must ensure that no part of their stand or stock block any fire exits within the venue.
- All exhibitors are required to have their own sufficient Public Liability Insurance. You will be required to show a copy when asked.
- Traders will be responsible for all H.S.E requirements applicable to their business operation whilst on the showground and should have a risk assessment.
- All official timetables set out by the Arley Estate for arrival, set up, de rig, departure, and show times must be strictly followed.
- No deviation from the specific space prior to or during the event is allowed without consultation and agreement with the Events Staff at Arley.
- Traders must keep their areas clean and litter free, and remove ALL packaging from site on departure.
- Refunds due to Trader cancellation will be payable at a rate of 50% if made on or before Friday 25 September 2026. No refunds will be made for any cancellations after that date.
- In the unlikely event we are forced to change or cancel the event date completely, Arley's liability will be limited to a transfer to the next appropriate date or a refund in full of the fee paid at the date of cancellation. We regret that we are unable to make a refund for non attendance on the day. Equally, we will not be liable for any loss, damage or expense caused by the cancellation of the event resulting from government action, strike, civil commotion, national disaster, inclement weather or other force majeure event which includes (but is not limited to) war, threat of war, riot, civil disobedience or strife, industrial dispute, terrorist activity, natural or nuclear disaster, fire or adverse weather conditions, technical or maintenance problems with transport and changes of schedule or operational decisions of any transport carrier.
